Give original and ALL copies of the form to service provider.

TO CLERK: 1. If program participation is ordered by the court or family support magistrate, enter court location and docket number at right and complete section I or II as appropriate. 2. Keep gold copy and give original and remaining copies to participant.

TO SERVICE PROVIDER: 1. Complete section IV and return original and green copy to the appropriate Family Division Office. 2. Give/send pink copy to participant. 3. Keep yellow copy for your records.

TO FAMILY SERVICES: 1. Upon receipt of Completion Certificate from service provider, complete section V and forward original to the superior court listed. 2. Keep green copy for your records.
